The Seller warrants that the Puppy listed is a purebred German Shepherd that will be registered with the Canadian Kennel Club, and has been sold as "Pet Quality". This shall be understood to mean that this dog will be subject to a limited CKC Registration "Non-Breeding Agreement" The Buyer agrees to take all measures necessary to ensure that the puppy is not bred, and does not have the opportunity to sire or deliver a litter. The Buyer agrees that the puppy will be spayed or neutered within 18 - 24 months after purchase unless the "Non-Breeding Agreement" is cancelled by the Seller. Seller agrees to remove or extend the Non-Breeding Clause should this puppy acquire or be in training for, Conformation or Working/Obedience title, has Hips and Elbows x-ray cleared of Dysplasia and meets the GSD Standard for consideration of breeding.

## PURCHASERS RESPONSIBILITY

The Purchaser is advised to have their puppy fully health checked upon their first veterinary visit – which should be for their second vaccine shot. If the purchaser’s veterinarian determines the puppy to be of poor health or have structural defects (excluding umbilical hernia, or undescended testicle) – the purchaser may return the puppy to the seller for refund. (Travel expenses incurred are the responsibility of the purchaser also the puppy must be returned in the same condition and health or the seller’s warranty is void - a signed statement from the examining veterinarian is required). The purchaser agrees to take good and proper care of this puppy and the puppy will reside at the home of the purchaser. The dog will be given adequate shade and housing, have access to a secure exercise area (yard), and will be properly and sufficiently fed. The dog will receive proper veterinary care throughout its lifetime, including annual (or as recommended) vaccinations to ensure preventative health care. He shall not be allowed to run loose in the purchaser’s community, nor shall be kept chained or tied up. The dog is never to be transported in the back of an open pickup truck, or mistreated or abused. **Under terms of this contract, the seller has the right to investigate the care of this puppy if circumstances warrant. If it is proven that the Dog is the subject to any abuse or mistreatment not limited to the above concerns, where the dog’s health or life may be threatened, the seller has the right to take possession of the dog and all warranties are then void.** This dog shall not be used for purposes of vivisection or research. Purchaser agrees that the purchaser is not acting as an agent in the purchase of this puppy. Purchaser also agrees that this dog shall not be sold by or through any commercial broker or wholesale establishment, any chain store, catalog sales house, pet store or "Puppy mill" Purchaser guarantees the Seller the right of first refusal if the dog is to be sold or disposed of in any way. DO NOT FEED PUPPY FOOD, use a quality Adult or All Life Stage Food only.

## PUPPY WARRANTY

1. The puppy is warranted to be free of hip dysplasia.  
\* *No Puppy can be guaranteed for never having a hip dysplasia condition - however, every step has been made to ensure that the parents and bloodlines reflect a strong OFA background. The puppy would be replaced should the occurrence of a serious hip dysplasia condition be evident by the age of two subject to the conditions below.*
2. Seller will refund the total purchase price for any health / temperament reason within 72 hours. (reservation fee / Deposit – may be retained if this puppy was reserved).
3. Seller will replace the puppy should the dog be diagnosed with any serious hereditary defect that will affect the dog’s quality of life until the dog reaches the age of two years. (excluding umbilical hernia or undescended testicle) This is subject to our selected veterinarian confirmation of the dogs condition and having full access to all medical records and history and the dog being returned to our property at the owners expense.
4. Temperament – The temperament of the puppy is not warranted after 72 hours as the manner in which the puppy is raised and the environment it resides in is out of control of the seller.
5. Ears. Are not guaranteed to “Stand” but as the breeder we will make every effort to assist in getting them erect.

## FURTHER CONDITIONS OF WARRANTY

All warranties are void if the dog has ever been bred, or sold, or has been subject to trauma which could have a marked effect on the claimed condition. This warranty does not cover costs of health checks, treatments or surgeries. Purchaser agrees to maintain preventative care of the puppy in regards to hip dysplasia such as proper nutrition, exercise, and preventing stress injuries (ex. Not allowing young puppies to jump from heights taller than itself at the shoulder and no FORCED EXERCISING, especially running, until at least 18 months of age.) Seller agrees to be accessible to answer any questions and will provide support to the best of the Sellers ability. In The event that a replacement puppy is to be provided. The Seller reserves the right to have the original dog returned and the choice of the replacement puppy and its pedigree to be at the discretion of the Seller. Any travel / shipping costs to be the purchaser’s responsibility. Seller reserves the right to refund the purchase price partially or in whole.

THE PURCHASER HAS READ AND UNDERSTANDS THE FOREGOING AND AGREES THAT ALL PARTS AND PORTIONS THEREOF CONSTITUTES A BINDING AGREEMENT. NO PART OF THIS CONTRACTUAL AGREEMENT IS TRANSFERABLE. FURTHER, SIGNATURES BELOW ACKNOWLEDGE RECEIPT OF A COPY OF THIS CONTRACT BY THE PURCHASER.
