The Seller warrants that the Puppy listed is a purebred German Shepherd that will be registered with the Canadian Kennel Club, and has been sold as "Showable". "Showable" shall be understood to mean that this dog is genetically free of all disqualifying faults and embodies the basic standard of the breed. The dog is not guaranteed to win in the show ring, however it is understood that with proper care and training on the part of the buyer, in due time the dog could be expected to win in the conformation ring.

Seller agrees that the Puppy is in good health and has received appropriate care, medical -vaccinations and worming as detailed in your German Shepherd Puppy Manual Provided.

PURCHASERS RESPONSIBILITY

The Purchaser agrees to take this puppy to a licensed veterinarian within 72 hours of purchase for a health check. If the purchaser's veterinarian determines the puppy to be ill, or for any reason this puppy is unacceptable, purchaser may return the puppy to the seller for a full refund. (Travel & Veterinary expenses incurred are the responsibility of the purchaser).

The purchaser agrees to take good and proper care of this puppy and the puppy will reside at the home of the purchaser. The dog will be given adequate shade and housing, have access to a secure exercise area (yard), and will be properly and sufficiently fed. The dog will receive proper veterinary care throughout its lifetime, including annual (or as recommended) vaccinations to ensure preventative health care. He shall not be allowed to run loose in the purchaser's community, nor shall be kept chained or tied up. The dog is never to be transported unsecured in the back of an open pickup truck, or mistreated or abused. Under terms of this contract, the seller has the right to investigate the care of this puppy if circumstances warrant. If it is proven that the Dog is the subject to any abuse or mistreatment not limited to the above concerns, where the dogs health or life may be threatened, the seller has the right to take possession of the dog and all warranties are then void. No Monies refunded.

This dog shall not be used for purposes of vivisection or research. Purchaser agrees that the purchaser is not acting as an agent in the purchase of this puppy. Purchaser also agrees that this dog shall not be sold by or through any commercial broker or wholesale establishment, any chain store, catalog saleshouse, pet store or "Puppy mill"

Purchaser guarantees the Seller the right of first refusal if the dog is to be sold or disposed of in any way.

PUPPY WARRANTY

1. The puppy is warranted to be free of hip dysplasia. *
2. Seller will refund the total purchase price for any reason within 72 hours.
3. Seller will replace the puppy should the dog be diagnosed with any serious hereditary defect that will affect the dog's quality of life for a period of two years.

* No Puppy can be guaranteed for never having a hip dysplasia condition - however, every step has been made to ensure that the parents and bloodlines reflect a strong OFA / OVC background. The puppy would be replaced should the occurrence of a serious hip dysplasia condition be evident. (Failed attempt to register the dogs x-rays with OVC or OFA) by the age of 26 months or mutual agreement on x-ray results. Subject to the conditions below.

FURTHER CONDITIONS OF WARRANTY

All of the above are subject to verification by the veterinarian of the Seller's choice. All warranties are void if the dog has ever been bred, or sold, or has been subject to trauma which could have a marked effect on the claimed condition. This warranty does not cover costs of health checks, treatments or surgeries of any kind. Purchaser agrees to maintain preventative care of the puppy in regards to hip displasia such as proper nutrition, exercise, and preventing stress injuries (ex. Not allowing young puppies to jump from heights taller than itself at the shoulder and no FORCED exercising, especially running, until at least 18 months of age) Remember that your puppies bone/ joint growth rate & plates are not complete yet. Seller agrees to be accessible to answer any questions and will provide support to the best of the Sellers ability. In The event that a replacement puppy is to be provided. The Seller reserves the right to have the original dog returned and the replacement puppy to be available within one calendar year. Any travel / shipping costs to be the purchasers responsibility .

THE PURCHASER HAS READ AND UNDERSTANDS THE FOREGOING AND AGREES THAT ALL PARTS AND PORTIONS THEREOF CONSTITUTES A BINDING AGREEMENT. NO PART OF THIS CONTRACTUAL AGREEMENT IS TRANSFERABLE. FURTHER, SIGNATURES BELOW ACKNOWLEDGE RECEIPT OF A COPY OF THIS CONTRACT BY THE PURCHASER.
